Interment Permit Application

Please complete the following permit application and submit it to the Crested Butte Town Clerk's office at 507 Maroon Avenue in Crested Butte, CO or mail to P.O. Box 39 Crested Butte, CO 81224. The Town of Crested Butte is responsible for all excavation work related to casket interments at the Crested Butte Cemetery. Excavation work for cremain interments may be conducted by family members or friends after an interment permit has been approved. The Town is available to excavate for cremain interments if preferred. No interment will be scheduled until all necessary fees have been paid and the interment permit has been approved. The fees for the excavation work are as follows:

- Casket Burial (Weekdays) \$400
- Casket Burial (Winter Weekdays) Case by case basis-ask Clerk's Office
- Casket Burial (Weekends, Holidays, Emergencies) \$550
- Casket Burial (Winter Weekends, Holidays, Emergencies) Case by case basis-ask Clerk's Office
- Cremain Burial (Weekdays) \$200
- Cremain Burial (Winter Weekdays) Case by case basis-ask Clerk's Office
- Cremain Burial (Weekends, Holidays, Emergencies) \$350
- Cremain Burial (Winter Weekends, Holidays, Emergencies) Case by case basis-ask Clerk's Office
