AN ORDINANCE AMENDING CERTAIN
PROVISIONS OF THE TOWN CODE
RELATIVE TO SPECIAL EVENT PERMITS

WHEREAS, the Town of Crested Butte, Colorado (the "**Town**") is a home rule municipality duly and regularly organized and now validly existing as a body corporate and politic under and by virtue of the constitution and laws of the State of Colorado;

WHEREAS, Article 5-5, Special Event Permits, of the Crested Butte Town Code of 1986, as amended (the "**Town Code**"), contains certain requirements for non-profit enterprises and for for-profit enterprises to obtain a special event permit where the same are holding a special event;

WHEREAS, the Town staff has found these requirements require certain technical revisions such that approval of a special event permit shall not require a motion by the Town Council; and

WHEREAS, the Town Council has determined that such revisions, as reflected in this ordinance, accomplish the Staff's goals described above and are in the best interest of the general health, safety and welfare of the residents and visitors of the Town.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF CRESTED BUTTE, COLORADO, THAT,

Section 1. Amending Section 5-5-2, Special Event Permit Required.

Section 5-5-2 is hereby deleted in its entirety and replaced with the foregoing new Section 5-5-2:

"Section 5-5-2. – Special Event Permit Required. It shall be unlawful for any person to organize, maintain, operate or otherwise sponsor a special event without receiving prior approval from the Town. Events sponsored by the Town are exempt from the requirement for a special event permit. (Ord. 21, 2007, §5)"

Section 2. Severability. If any section, sentence, clause, phrase, word or other provision of this ordinance is for any reason held to be unconstitutional or otherwise invalid, such holding shall not affect the validity of the remaining sections, sentences, clauses, phrases, words or other provisions of this ordinance, or the validity of this ordinance as an entirety, it being the legislative intent that this ordinance shall stand notwithstanding the invalidity of any section, sentence, clause, phrase, word or other provision.

Section 3. Savings Clause. Except as hereby amended, the Town Code shall remain valid and in full force and effect. Any provision of any ordinance previously adopted by the Town which is in conflict with this ordinance is hereby repealed as of the enforcement date hereof.
