**A RESOLUTION DESIGNATING A TOWN OF
CRESTED BUTTE TEMPORARY OFFICIAL PUBLIC
PLACE FOR POSTING TOWN COUNCIL
MEETINGS AND OTHER IMPORTANT ITEMS
WHILE THE PREVIOUSLY DESIGNATED OFFICIAL
POSTING PLACE IS UNAVAILABLE**

WHEREAS, the Town of Crested Butte, Colorado (the "Town") is a home rule municipality duly and regularly organized and now validly existing as a body corporate and politic under and by virtue of the Constitution and laws of the State of Colorado; and

WHEREAS, Colorado Revised Statutes, section 24-6-402 (2) (c) requires that each Colorado municipality annually designate an official public posting place for notices announcing Town Council meetings and other important items; and

WHEREAS, Article 4.11 of the Town Charter requires that, after adoption of an ordinance, copies of the ordinance shall be posted in three public places within Town; and

WHEREAS, Resolution No. 17, Series 2009 designates the Town's official posting places as the following three locations for the purposes of posting notices announcing Town Council meetings and other important items, and for posting copies of ordinances after adoption: 1) outside the reception office in the Town Offices, located at 507 Maroon Avenue; 2) the Crested Butte Library, located at 507 Maroon Avenue; and 3) the lobby of the Old Town Hall, located at 132 Elk Avenue in Crested Butte, Colorado; and

WHEREAS, the lobby of the Old Town Hall, located at 132 Elk Avenue in Crested Butte, Colorado will be undergoing a remodel and the posting location will be temporarily unavailable; and


WHEREAS, the Town wishes to officially designate the lobby of the Marshal's Office located at 508 Maroon Avenue in Crested Butte, Colorado as the official public posting place for the purposes of posting notices announcing Town Council meeting and other important items, and for posting copies of ordinances after adoption for the duration of the time that the previously designated lobby of the Old Town Hall will be unavailable.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CRESTED BUTTE, COLORADO:

That for the duration that the lobby of the Old Town Hall, located at 132 Elk Avenue in Crested Butte, Colorado, is unavailable the Town's official public posting places for posting notices announcing Town Council meeting and other important items, and for posting copies of ordinances after adoption, are hereby designated as: 1) outside the reception office in the Town Offices, located at 507 Maroon Avenue; 2) the Crested Butte Library, located at 507 Maroon Avenue; and 3) the lobby of the Marshal's Office located at 508 Maroon Avenue in Crested Butte, Colorado; and that once the lobby of the Old Town Hall, located at 132 Elk Avenue in Crested Butte, Colorado again becomes available the Town's official public posting places for posting notices announcing Town Council meeting and other important items, and for posting copies of ordinances after adoption will default back to the locations previously adopted in Resolution No. 17, Series 2009.
