

**ORDINANCE NO. 2**

**SERIES 2014**

**AN ORDINANCE AMENDING CHAPTER 2, ARTICLE 2 OF THE CRESTED BUTTE MUNICIPAL CODE TO ELIMINATE THE REQUIREMENT THAT REGULAR TOWN COUNCIL MEETINGS BE HELD AT 7:00 P.M. ON THE FIRST AND THIRD MONDAYS OF EACH MONTH AND INSTEAD BE HELD AT SUCH TIME AS THE TOWN COUNCIL SHALL ELECT FROM TIME-TO-TIME ON THE FIRST AND THIRD MONDAYS OF EACH MONTH**

WHEREAS, the Town of Crested Butte, Colorado ("**Town**") is a home rule municipality duly and regularly organized and now validly existing as a body corporate and politic under and by virtue of the Constitution and laws of the State of Colorado;

WHEREAS, Article 4, Section 4.1 of the Home Rule Charter of the Town of Crested Butte (the "**Charter**") requires that the Town Council meet regularly at least twice each month at a day and hour to be fixed by the Town Council;

WHEREAS, Chapter 2, Article 2 of the Crested Butte Municipal Code (the "**Code**") requires that regular meetings of the Town Council shall be held on the first and third Mondays of each month at Town Hall at 7:00 p.m.;

WHEREAS, the Town Council desires to amend the Code so as to allow the Town Council to more freely set the hour for meetings for regular Town Council meetings on the first and third Mondays of each month from time-to-time;

WHEREAS, the Town Council finds that such amendments to the Code are consistent with the intent and purposes of the Charter and other provisions of the Code, including, without limitation, the Town Council procedures set forth therein; and

WHEREAS, the Town Council finds that it is in the best interest of the health, safety and general welfare of Crested Butte's residents and visitors to amend the Code so as to allow the Town Council to more freely set the hour for meetings for regular Town Council meetings on the first and third Mondays of each month from time-to-time as set forth below.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF CRESTED BUTTE, COLORADO, THAT,

**Section 1. Amending Section 2-2-30, Regular Meetings.** Section 2-2-30 of the Code is hereby deleted in its entirety and replaced with the following new Section 2-2-30 that shall read as follows:

**“Sec. 2-2-30. Regular meetings.**

The regular meetings of the Town Council shall be held on the first and third Mondays of each calendar month at Town Hall at a time to be set from time-to-time by the Town Council, except that no meeting shall be held on a legal holiday.”

**Section 2. Severability.** If any section, sentence, clause, phrase, word or other provision of this Ordinance is for any reason held to be unconstitutional or otherwise invalid, such holding shall not affect the validity of the remaining sections, sentences, clauses, phrases, words or other provisions of this Ordinance, or the validity of this Ordinance as an entirety, it being the legislative intent that this Ordinance shall stand notwithstanding the invalidity of any section, sentence, clause, phrase, word or other provision.

**Section 3. Savings Clause.** Except as amended hereby, the Crested Butte Municipal Code, as amended, shall remain valid and in full force and effect. Any provision thereof that is in conflict with this ordinance is hereby repealed as of the enforcement date hereof.


