

**PLANTING NOTES & SPECIFICATIONS:**

1. THE PLANTING PLAN IS DIMENSIONAL. ALL PLANT LOCATIONS ARE APPROXIMATE. QUANTITIES SHOWN ON THE PLAN TAKE PRECEDENCE OVER PLANT QUANTITIES SPECIFIED WITHIN THE SCHEDULES.
2. CONTRACTOR SHALL VERIFY THE LANDSCAPE ARCHITECT'S OR THE DISCREPANCIES BETWEEN QUANTITIES AND SYMBOLS SHOWN.
3. ANTIPOUR CONTRACTOR SHALL VERIFY A CONTRACT NUMBER IS PRESENT FOR ALL MANUFACTURER'S CONTRACTS. THE BACK INCLUDING THE ROOTS BEFORE BEGINNING WORK.
4. PLANTS SHALL EXHIBIT HEALTHY GROWTH AND BE FREE OF DISEASES & PESTS.
5. ALL CONTAINERED PLANTS NEED TO BE TOE OF CONTAINER & HOLD ROOT BALL TOGETHER.
6. PRIOR TO PLANTING THE REBARATION SYSTEM SHALL BE FULLY OPERATIONAL AND PLANTING AREAS SHALL BE FIRMED.
7. ALL PLANTS SHALL BE PLANTED IN THIS WAY: A MINIMUM DETERMINED BY 50 PERCENT OF THE PLANT'S TOTAL ROOT BALL OR CONTAINER VOLUME.
8. FERTILIZER SHALL BE BACKFILLED WITH A 1/2" OF TOPSOIL & COMPOST TO A DEPTH OF 6".
9. ALL TREES SHALL HAVE THE ROOT GROWN PLANTED 2" ABOVE THE APPROXIMATE FINISHED GRADE. ALL TREES SHALL HAVE THE ROOT GROWN PLANTED 1" ABOVE THE APPROXIMATE FINISHED GRADE.
10. ALL TREES SHALL HAVE ALL TRUNK OR OTHER BRANCHING MATERIAL REMOVED ABOVE GROUND OR TRUNK. ALL TREES SHALL BE PLANTED WITH THE TRUNK OR OTHER BRANCHING MATERIAL PROTECTIVE WRAPPING OR THE TRUNK WRAPPED WITH PROTECTIVE WRAPPING.
11. ALL TREES SHALL BE PLANTED WITH TWO (2) INCHES SPACED BARK MOUND PROTECTIVE DIRT.
12. ALL TREES SHALL BE PLANTED WITH TWO (2) INCHES SPACED BARK MOUND PROTECTIVE DIRT.
