

**ORDINANCE NO. 18
SERIES 2006**

AN ORDINANCE ADOPTING THE BUDGET AND APPROPRIATING SUMS OF MONEY FOR THE TOWN OF CRESTED BUTTE, COLORADO FOR THE FISCAL YEAR BEGINNING THE FIRST DAY OF JANUARY 2007, AND ENDING THE LAST DAY OF DECEMBER 2007, ESTIMATING THE AMOUNT OF MONEY NECESSARY TO BE DERIVED FROM REVENUE SOURCES, AND SETTING FORTH THE TOTAL ESTIMATED EXPENDITURES FOR EACH FUND.

WHEREAS, the Town Manager is directed to prepare the annual budget for the Town of Crested Butte, Colorado for the fiscal year beginning January 1, 2007, and ending December 31, 2007, and has prepared said budget and submitted to the Town Council, and

WHEREAS, the Town Council has reviewed the proposed budget as submitted by the Town Manager and is fully advised in the premises, and

WHEREAS, upon due and proper notice, published in accordance with the law, said proposed budget was open for inspection by the public at the Town Hall, so that interested taxpayers could be given the opportunity to file or register any objections to said proposed budget at the Council meetings when budget was set for public hearing, and then heard, and

WHEREAS, the Town Council has held its public hearing, and

WHEREAS, whatever increases may have been made in the expenditures, like increases were added to the revenues so that the budget remains in balance, as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CRESTED BUTTE, COLORADO:

That the following expenditures for the various funds of the Town of Crested Butte be as follows:

GENERAL FUND	\$2,859,021
(The General Fund budget includes Highway Users money in the amount of \$41,991. The Public Works department is covered in part by these funds.)	
GENERAL CAPITAL FUND	\$2,243,083
SEWER & WATER FUND	\$1,570,947
STREET & ALLEY FUND	\$1,847,407

CONSERVATION TRUST FUND	\$ 30,000
SALES TAX FUND	\$2,230,375
AFFORDABLE HOUSING FUND	\$ 346,000
TOTAL	\$11,126,833

That the budget for the Town of Crested Butte, Colorado for the fiscal year beginning January 1, 2007, and ending December 31, 2007, as heretofore submitted to the Town Council by the Town Manager is hereby adopted and approved as the Budget for the Town of Crested Butte, Colorado for said fiscal year.
