A RESOLUTION ADOPTING THE APPLICABLE PROVISIONS OF THE UNIFORM ELECTION CODE OF 1992 FOR THE COORDINATED ELECTION TO BE HELD ON NOVEMBER 3, 2009 AND AUTHORIZING THE TOWN CLERK TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE GUNNISON COUNTY CLERK CONCERNING ADMINISTRATION OF THAT ELECTION

WHEREAS, the Town of Crested Butte, Colorado is a home rule municipality duly and regularly organized and now validly existing as a body corporate and politic under and by virtue of the Constitution and laws of the State of Colorado; and

WHEREAS, the Town Charter provides at Section 2.1 that Town elections shall be governed by the Colorado Municipal Election Laws; and

WHEREAS, Section 31-10-102.7 of the Colorado Revised Statutes (C.R.S.), the Colorado Municipal Election Law, provides that any municipality may provide by ordinance or resolution that it will utilize the requirements and procedures of the Uniform Election Code of 1992 in lieu of the Municipal Election Code; and

WHEREAS, pursuant to said section, the Town Council herein provides that it will utilize the requirements and procedures of the Uniform Election Code of 1992 for the November 3, 2009 election; and

WHEREAS, pursuant to the Crested Butte Municipal Code and Section 29-1-203, C.R.S., the Town is authorized and empowered to contract with another governmental entity or district to provide any function, service or facility lawfully authorized to be provided by either of the cooperating or contracting units of government; and

WHEREAS, the Town and the Gunnison County Clerk wish to enter into a contract for the purpose of conducting the November 3, 2009 election as a coordinated election.


NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CRESTED BUTTE, COLORADO,

1. The Town of Crested Butte hereby resolves to utilize the requirements and procedures of the Uniform Election Code of 1992 in lieu of the Municipal Election Code for the November 3, 2009 election.


