

**ORDINANCE NO. 6
SERIES 2021**

**AN ORDINANCE OF THE CRESTED BUTTE TOWN COUNCIL
AMENDING AND REPLACING CRESTED BUTTE MUNICIPAL CODE
CHAPTER 8, ARTICLE 2, SECTION 60, DESIGNATED LOADING ZONES.**

WHEREAS, the Town of Crested Butte, Colorado ("**Town**") is a home rule municipality duly and regularly organized and now validly existing as a body corporate and public under and by virtue of the Colorado Constitution and laws of the State of Colorado; and

WHEREAS, pursuant to Article XX of the Colorado Constitution, as implemented through the Town of Crested Butte Charter; and Title 31, Article 23, and Title 20, Article 29, C.R.S.; the Town has the authority to enact and enforce land use regulations; and

WHEREAS, Chapter 8, Article 2, Section 60, of the Crested Butte Municipal Code (the "Code"), regulates designated loading zones; and

WHEREAS, the Town Council wishes to facilitate efficient access of delivery vehicles to stores and restaurants by designating certain loading zones on Elk Avenue and 2nd Street; and

WHEREAS, the Town Council finds that the below amendments to Chapter 8, Article 2, Section 60 of the Code are in the best interests of the health, safety and general welfare of the Town.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF CRESTED BUTTE, COLORADO, THAT CHAPTER 8, ARTICLE 2, SECTION 60 OF THE CODE IS AMENDED AND REPLACED WITH THE FOLLOWING PROVISIONS:

Section 1. Amending Chapter 8 Article 2 Section 60 - Designated Loading Zones

Sec. 8-2-60. Designated Loading Zones.

Between the hours of 8:00 a.m. through 5:00 p.m., Monday through Friday, no parking at all shall be permitted in the designated loading zones located:

- (1) On the north side of Elk Avenue, between First Street and Second Street. This designated loading zone is approximately seventy (70) feet in length.
- (2) On the east side of 2nd Street, between Coal Creek and Elk Avenue. This designated loading zone is approximately sixty-four (64) feet in length.
- (3) On the north side of Elk Avenue, between 2nd Street and 3rd Street. This designated loading zone is approximately seventy (70) feet in length.
- (4) On the north side of Elk Avenue, between 3rd Street and 4th Street. This designated loading zone is approximately thirty-eight (38) feet in length.

Between the hours of 8:00 a.m. through 5:00 p.m., Monday through Friday, parking shall be permitted for a maximum of ten minutes per vehicle in the designated loading zones located:

- (1) On the north side of Elk Avenue, between 2nd Street and 3rd Street, the designated loading zone is approximately forty (40) feet in length.

Section 2. Severability. If any section, sentence, clause, phrase, word or other provision of this ordinance is for any reason held to be unconstitutional or otherwise invalid, such holding shall not affect the validity of the remaining sections, sentences, clauses, phrases, words or other provisions of this ordinance, or the validity of this ordinance as an entirety, it being the legislative intent that this ordinance shall stand notwithstanding the invalidity of any section, sentence, clause, phrase, word or other provision.


Section 3. Savings Clause. Except as amended hereby, the Crested Butte Municipal Code, as amended, shall remain valid and in full force and effect. Any provision of the Code that is in conflict with this ordinance is hereby repealed as of the effective date hereof.

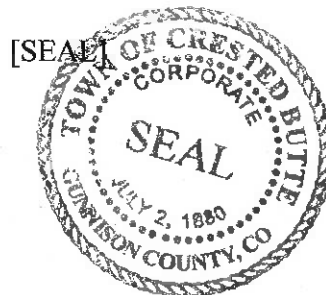

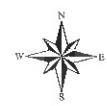
