

**RESOLUTION NO. 23
SERIES 2020**

A RESOLUTION OF THE CRESTED BUTTE TOWN COUNCIL ADOPTING THE BUDGET AND APPROPRIATING SUMS OF MONEY FOR THE TOWN OF CRESTED BUTTE, COLORADO FOR THE FISCAL YEAR BEGINNING THE FIRST DAY OF JANUARY 2021, AND ENDING THE LAST DAY OF DECEMBER 2021, ESTIMATING THE AMOUNT OF MONEY NECESSARY TO BE DERIVED FROM REVENUE SOURCES, AND SETTING FORTH THE TOTAL ESTIMATED EXPENDITURES FOR EACH FUND.

WHEREAS, the Town Manager is directed to prepare the annual budget for the Town of Crested Butte, Colorado for the fiscal year beginning January 1, 2021, and ending December 31, 2021, and has prepared said budget and submitted to the Town Council; and

WHEREAS, the Town Council has reviewed the proposed budget as submitted by the Town Manager and is fully advised in the premises; and

WHEREAS, upon due and proper notice, published in accordance with the law, said proposed budget was open for inspection by the public on the Town's website, so that interested taxpayers could be given the opportunity to file or register any objections to said proposed budget at the Council meetings when budget was set for public hearing, and then heard; and

WHEREAS, the Town Council has held its public hearing.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF CRESTED BUTTE, COLORADO:

That the following expenditures for the various funds of the Town of Crested Butte be as follows:

GENERAL FUND	\$ 5,413,750
GENERAL CAPITAL FUND	\$ 1,740,480
SEWER & WATER FUND	\$ 2,807,509
STREET & ALLEY FUND (The Street & Alley Fund budget includes Highway Users money in the amount of \$40,000.)	\$ 857,129
CONSERVATION TRUST FUND	\$ 0
AFFORDABLE HOUSING FUND	\$ 252,500
TOTAL	\$11,061,368
