**RESOLUTION OF THE CRESTED BUTTE TOWN

COUNCIL REGARDING TOWN PARTICIPATION ON
BOARDS AND COMMITTEES**

WHEREAS, the Town of Crested Butte, Colorado (the "Town") is a home rule municipality, duly and regularly organized and now validly existing as a body corporate and politic under and by virtue of the Constitution and laws of the State of Colorado; and

WHEREAS, Section 4.7 of the Crested Butte Town Charter provides that the Council may act, other than legislatively, by resolution; and

WHEREAS, questions have arisen over the past few months regarding the role of Town Council members and their participation on various boards and committees as it relates to the Code of Conduct; and

WHEREAS, in January, 2021 the Town Council discussed participation on boards and committees and determined they would like to establish a policy to provide guidance to staff and Council in considering which boards and committees to participate on and understanding any limitations of participation under the Code of Conduct in Chapter 2, Article 4 of the Municipal Code; and

WHEREAS, the Town Council has reviewed the policy for Town Participation on Boards and Committees (the "Policy") and approves the policies set forth in the Policy for ex-officio participation on boards and committees; and

WHEREAS, the Town Council finds that the Policy is in the best interest of the health, safety and welfare of the Town, its residents and visitors.





TOWN PARTICIPATION ON BOARDS AND COMMITTEES

Introduction or Purpose:

The Town Participation on Boards and Committees Policy (the "Policy") of the Town Council of the Town of Crested Butte (the "Town") is established to provide guidance to staff and Council in considering which Boards and Committees to participate on and understanding any limitations of participation under the Code of Conduct in Chapter 2, Article 4 of the Municipal Code.

Town Council has determined that participation on various boards and committees is important to fulfill obligations established through intergovernmental agreements, reinforce the Town's interest in certain governmental activities, and maintain open lines of communication with certain entities.

The Code of Conduct defines conflicts of interest and places limitations on Council members and staff and prohibits them from participating in the Council discussion and decision if there is a conflict of interest. This policy clearly identifies where a conflict could exist through service on a board or committee and provides a framework to avoid such conflicts.

Scope:

The Policy applies to the Town's participation on various boards and committees, and the role of Council members or staff when participating on boards and committees as an appointee of the Town Council. All appointments to boards and committees are subject to review and approval by the Town Council.

Policy:

The Town Council has identified four categories: Town Committees established by the Town itself, Governmental Organizations, Non-voting Attendees, and Community Non-Profits/Organizations.

Some organizations have established "ex officio" positions on their boards to be filled by a Town Council member. An ex officio director is one who serves on a board by virtue of his/her position as a Crested Butte Town Council member. Ex officio directors are generally non-voting but it depends on the organization. Under this policy, no Council member may serve as an ex officio member of any organization without formal approval by vote of the Town Council.

Town Committees are those committees that have been formed directly by the Town Council with the purpose of advising on specific programs or activities of the Town as set forth by the Council. Council members or staff appointed by the Council can fully participate as members of the boards for these committees. They can also fully participate in Town Council discussions and decisions involving these organizations.

Governmental Organizations are defined as those entities that are formed through an inter-governmental agreement and/or member organizations of which the Town itself is a member.

Council members or staff appointed by the Council can fully participate as members of the boards for these types of organizations. They can also fully participate in Town Council discussions and decisions involving these organizations.

Non-voting Attendees are the category of boards or committees for which the Town is either obliged to have a representative attend through a written agreement with the entity, or for which the Town Council has determined that someone should observe the proceedings to be able to inform the Council of that board's activities. Whenever a Town Council member or staff is a non-voting attendee, they can attend the meetings of the organization and fully participate in Town Council discussions and decisions involving these organizations.

Community Non-Profits/Organizations are non-governmental organizations that are independent from the Town. The Town Council may choose to appoint Council members or staff to participate as representatives to these types of organizations, but it is the intent of this policy to avoid actual conflicts of interest or the appearance of a conflict of interest whenever possible. Thus, Council will only appoint Council members to Non-profit/Community Organizations after careful review and consideration.

Depending on the organization, Town Council may be making appointments to the board of the organization either as a regular or ex officio member of the organization's board. If Town Council appoints members of the Council to the boards of these types of organizations, whether or not they are ex officio, this policy prohibits Council members from participating in Town Council discussions regarding financial awards to the organization under the Code of Conduct.

Further, if a member of the Town Council chooses to participate on a board or committee in the community independent of their role on the Town Council (not representing the Town), he/she may do so. However, under the Code of Conduct they must recuse themselves from any Town Council discussions regarding financial awards to the organization.
